**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF DP  
COUNCIL SUMMIT - COLLATERALS AND TOKENS**

---

**WHEREAS**, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, as technology continues to advance, the processing of personal information continues to evolve. The safeguarding of personal information has become a paramount concern for both individuals and organizations. To ensure the effective protection of personal information, it is imperative that stakeholders are knowledgeable and compliant with the Data Privacy Act of 2012 (DPA) and issuances of the National Privacy Commission (NPC);

**WHEREAS**, Data Privacy Training Roadshow: Operationalizing the DPA in pursuit of strengthening data privacy knowledge and compliance. This event will provide comprehensive lectures on the fundamentals of the DPA. The Roadshow is geared towards strengthening data privacy competency, particularly in operationalizing the privacy laws in these strategic locations and equipping Data Protection Officers (DPOs) with the tools necessary to assess the level of their organizations' compliance with the DPA or get an affirmation on the implementation therein;

**WHEREAS**, the NPC approved its FY 2024 Annual Procurement Plan (APP) which include the Procurement of DP Council Summit – Collaterals and Tokens under APP Item No. 2024-0064 with the Approved Budget for the Contract (ABC) of One Hundred Fifty Thousand Pesos (PHP150,000.00);

**WHEREAS**, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes Small Value Procurement (SVP) as alternative mode of procurement to promote economy and efficiency;

**WHEREAS**, on 06 November 2024, the NPC Bids and Awards Committee (NPC-BAC) sent Request for Quotation (RFQ), through electronic email. The RFQ was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

**WHEREAS**, on 12 November 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation from two (2) prospective bidders based on requirements mandated under RA 9184 and its IRR;

**WHEREAS**, as stated in the Technical Specification, the end-user required a post-qualification requirement stating that the qualified bidder shall submit a sample copy prior to the issuance

of the Notice of Award to determine the qualified bidder complies and is responsive to the technical specifications;

**WHEREAS**, the BAC Members determined that one prospective supplier is compliant with the requirements subjected to post-qualification: Zioneyes General Merchandise. It was moved and seconded that the supplier undergo post-evaluation/qualification as stated in the technical specification;

**WHEREAS**, a Memorandum dated 18 November 2024 is hereto attached as "**Annex A**" from the end-user containing their recommendation that Zioneyes General Merchandise is compliant with the technical specification based on the Inspection Checklist and Assessment;

**WHEREAS**, the NPC-BAC likewise determined that Zioneyes General Merchandise submitted the single calculated and responsive quotation amounting to One Hundred Eleven Thousand Pesos (Php111,000.00);

**WHEREAS**, a Memorandum dated 22 November 2024 is hereto attached as "**Annex B**" from the end-user request for change of delivery date of the of DP Council Summit – Collaterals and Tokens;

**WHEREAS**, on 22 November 2024, the NPC Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that Zioneyes General Merchandise has the single calculated and responsive quotation with a bid price amounting to One Hundred Eleven Thousand Pesos (Php111,000.00);

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of **DP COUNCIL SUMMIT – COLLATERALS AND TOKENS** to **ZIONEYES GENERAL MERCHANDISE** for being the single calculated and responsive quotation with the total amount of **ONE HUNDRED ELEVEN THOUSAND PESOS (PHP111,000.00)**, subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).
