RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF COMPLIANCE AND SECURITY MONITORING COMMAND CENTER (CSMCC) - VAPT (APP Item No.2024-0085)

WHEREAS, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the Commission through the Compliance and Monitoring Division shall subject the NPC's public facing systems to a Vulnerability Assessment and Penetration Test;

WHEREAS, the main objective of the procurements is to ensure that all public facing systems of the NPC are secure and compliant with the provisions of NPC Circular 2023-06;

WHEREAS, this procurement has a Certificate of Availability of Funds (CAF) and is confirmed to be existing in the FY 2024 Annual Procurement Plan with APP Item No. 2024-0085 and with an Approved Budget for the Contract (ABC) of Six Hundred Thousand Pesos (PHP600,000.00);

WHEREAS, Section 53.9 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes Small Value Procurement (SVP) as an alternative mode of procurement to promote economy and efficiency;

WHEREAS, on 15 December 2024, the NPC Bids and Awards Committee (NPC-BAC) sent Request for Quotation (RFQ), through electronic email. The RFQ was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

WHEREAS, on 24 December 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotation from five (5) prospective bidders based on requirements mandated under RA 9184 and its IRR;

WHEREAS, on 24 December 2024, the NPC Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that the WORLDTECH INFORMATION SOLUTIONS, INC. has the lowest calculated and responsive quotation with a bid price amounting to Three Hundred Fifty Thousand Four Hundred Seventy-Five Pesos (Php350,475.00);

NOW, THEREFORE, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee hereby RESOLVE, as it is hereby RESOLVED, to recommend the award of contract for the procurement of COMPLIANCE AND SECURITY MONITORING COMMAND CENTER (CSMCC)-VAPT to WORLDTECH INFORMATION SOLUTIONS, INC. with the total amount of Three Hundred Fifty
