**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PH  
NATIONAL STANDARDS SUBSCRIPTION**

---

**WHEREAS**, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, the NPC's Data Security and Technology Standards Division (DTSTSD) is responsible for developing and issuing guidelines on physical and technical security measures for data protection using the most appropriate standards recognized by the information and communication technology industry;

**WHEREAS**, at present, the members of the DTSTSD are members of the International Organization for Standardization (ISO) and International Electrotechnical Commission (IEC) Joint Technical Committee on Information Technology Subcommittee on Information Security, Cybersecurity and Privacy Protection (ISO/IEC JTC 1/SC 27), and Joint Technical Committee on Information Technology Subcommittee on Artificial Intelligence (ISO/IEC JTC 1/SC 42);

**WHEREAS**, this procurement has a Certificate of Availability of Funds (CAF) and is confirmed to be existing in the FY 2024 Annual Procurement Plan with APP Item No. 2024-0087 and with Approved Budget for the Contract (ABC) of Fifty Thousand Pesos (PHP50,000.00);

**WHEREAS**, section 53.5 of R.A. 9184 allows to engage the services of the appropriate RGP through an Agency-to-Agency agreement. The appropriate RGP engaged by the procuring entity shall directly undertake the printing services for the contracts entered into, and cannot engage, subcontract, or assign any private printer to undertake the performance of the printing service;

**WHEREAS**, the DTSTSD submitted their justification (attached as Annex "A") stating that DTI-BPS' exclusive legal mandate as the sole authorized distributor of PNS Standards in the Philippines, combined with significant cost savings and operational efficiencies, proceeding with the Agency-to-Agency procurement represents the most advantageous option for the government;

**WHEREAS**, on 16 November 2024, the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation (RFQ) through electronic mail and the same was also posted on the NPC website as well as the NPC bulletin board;

**WHEREAS**, on 22 November 2024, the National Privacy Commission – Bids and Awards Committee (NPC-BAC) proceeded to evaluate of the submitted Justification of the End-User

and the Price Quotation by the Department of Trade and Industry -Bureau of Philippine Standards (DTI-BPS) amounting to Forty-Six Thousand Seven Hundred Twenty-Four Pesos (PHP46,724.00);

**NOW, THEREFORE**, for and in consideration of the foregoing, WE, the members of the NPC Bids and Awards Committee (NPC-BAC), hereby **RESOLVE**, as it is hereby **RESOLVED**, to recommend the award of contract for the procurement of **PH NATIONAL STANDARDS SUBSCRIPTION** to **DEPARTMENT OF TRADE AND INDUSTRY - BUREAU OF PHILIPPINE STANDARDS (DTI-BPS)** with the total amount of **FORTY SIX THOUSAND SEVEN HUNDRED TWENTY-FOUR PESOS (PHP46,724.00)**, subject to the presentation of their original documentary requirements upon the signing of the Notice of Award (NOA).



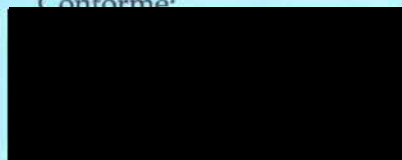
