**RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF  
INAUGURATION OF THE COMPLIANCE AND SECURITY MONITORING  
COMMAND CENTER (CSMCC) - REPRESENTATION  
(APP Item No. 2024-0102)**

**WHEREAS**, the National Privacy Commission (NPC or Commission) is an independent body mandated to administer and implement Republic Act No. 10173 of the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

**WHEREAS**, the NPC successfully completed the project Compliance and Security Monitoring Command Center (CSMCC). The Project aims to enhance the Commissions functions and provide real time analytics and appropriate decision- making in matters related to privacy and security. With this operation of the CSMCC and is set to be launched during its Inauguration on 19 December 2024;

**WHEREAS**, the event will be attended by all NPC personnel. The Commission also invited esteemed guests from various government agencies;

**WHEREAS**, the NPC approved its FY 2024 Annual Procurement Plan (APP), which includes the procurement of Inauguration of the Compliance Security Monitoring Command Center (CSMCC) - Representation under APP Item No. 2024-0102 with the Approved Budget for the Contract (ABC) of One Hundred Thousand Pesos (PHP100,000.00);

**WHEREAS**, on 18 December 2024, the NPC Bids and Awards Committee (NPC-BAC), through its Secretariat, sent Requests for Quotation (RFQ) through electronic mail to Via Mare Corporation. The Request for Quotation was also posted on the NPC websites as well as the NPC bulletin board;

**WHEREAS**, on 18 December 2024, the National Privacy Commission - Bids and Awards Committee (NPC-BAC) evaluated the submitted eligibility documents/quotations and found that Via Mare Corporation is the single calculated and responsive quotation, with a bid price of Ninety-Five Thousand Nine Hundred Pesos (Php95,900.00);


