RECOMMENDING THE AWARD FOR THE PROCUREMENT OF OTHER SUPPLIES – TOKENS/GIFT PASS (PREMIUM) (APP Item No. 2023-0078 & DSPQR 2023-0028)

WHEREAS, the National Privacy Commission (NPC) is the agency mandated to administer and implement Republic Act No. 10173 or the Data Privacy Act of 2012 and to monitor and ensure compliance of the country with international standards set for data protection;

WHEREAS, the NPC workforce has been working towards the organization's vision to be a world class regulatory and enforcement agency upholding the right to privacy and data protection while ensuring the free flow of information and commitment to excellence;

WHEREAS, in line with the approved Policy Guidelines on awards and Incentives for Service Excellence (PRAISE) of the NPC, all deserving employees will be recognized and rewarded with monetary and non-monetary incentives during the Annual Employees' Appreciation Day;

WHEREAS, the Administrative Service Division (ASD) proposed to procure tokens of appreciation/gratitude with equivalent monetary value, to serve as a memoir to strive harder, pursue excellence and continue personal development;

WHEREAS, the NPC approved its FY 2023 Annual Procurement Plan (APP) and the Digital Security and Privacy Quick Response (DSPQR) Project FY2023 APP which includes the procurement of Other Supplies – Tokens/Gift Pass (Premium) with APP Item No. 2023-0078 & DSPQR 2023-0028 with an Approved Budget of the Contract of ONE MILLION (Php1,324,000.00) charge against Office Supplies Expenses (GAS & OPERATIONS-MOOE);

WHEREAS, Section 50(b) of R.A. 9184 allows Direct Contracting for items, when the procurement of critical components from a specific supplier is a condition precedent to hold a contractor to guarantee its project performance, in accordance with the provisions of its contract;

WHEREAS, in its justification, the ASD stated that the purchase of Other Supplies – Tokens/Gift Pass (Premium) from Sodexo Benefits and Rewards Services Philippines, Inc. is offering a range of products designed to fit the diverse needs of Filipino consumers – the Sodexo Premium Pass with the broadest merchant network accepted in over 10,000 merchant outlets across the country;

WHEREAS, a Request for Quotation was sent to Sodexo Benefits and Rewards Services Philippines, Inc.;

WHEREAS, pursuant to such request, Sodexo Benefits and Rewards Services Philippines, Inc. sent its quotation with a total bid price of Php1,324,000.00, which is well within the ABC;
