# RECOMMENDING THE AWARD OF CONTRACT FOR THE PROCUREMENT OF PRINTERS (3-IN-1)

WHEREAS, the National Privacy Commission (NPC or Commission) established by the Data Privacy Act of 2012, has the clear and notable mandate to be the country's privacy watchdog. The daunting and challenging role is outline in its operational goals to ensure that data subject's RIGHT ARE PROMOTED, data subject RIGHT ARE PROTECTED, and to do the RIGHT THINGS RIGHT:

WHEREAS, in pursuit of the goal to have a safe and resilient digital environment, NPC endeavors to expand the cooperation between DICT and NPC to improved public service for the e-gov platform and consumer-related complaints and concern under the DICT and NPC. NPC aims to assist in the receipt, initial investigation, triaging, and initial response for both cybersecurity and data privacy concerns files with both agencies;

WHEREAS, this procurement has a Certification of Availability of Funds (CAF) with an Approved Budget for the Contract of Forty-Six Thousand Three Hundred Forty-Three Pesos (Php46,343.00) and has been confirmed to be existing as APP Item DSPQR 2023-0028;

WHEREAS, Section 53.10 of the 2016 Revised Implementing Rules and Regulations of Republic Act No. 9184 (2016 RIRR of RA 9184) recognizes Small Value Procurement (SVP) as alternative mode of procurement to promote economy and efficiency;

WHEREAS, on 15 November 2024, the NPC Bids and Awards Committee (NPC-BAC) sent Request for Quotation (RFQ), through electronic email. The RFQ was also posted on the PhilGEPS and NPC websites as well as the NPC bulletin board;

WHEREAS, four (4) bidders submitted their quotations, namely: (1) Accessories & Supplies Depot Inc, (2) BayanPC Technologies, Inc., (3) Silent Worker Marketing and (4) Otus Copy Systems, Inc;

WHEREAS, on 22 November 2024, the NPC Bids and Awards Committee (NPC-BAC) proceeded to evaluate the submitted quotations and determined that Silent Worker Marketing has the single calculated and responsive quotation with a bid price amounting to Thirty-Eight Thousand Two Hundred Twenty Pesos (Php38,220.00);
