## APPROVAL OF THE AMENDED FY2024 CONTINUING ANNUAL PROCUREMENT PLAN (APP Item No. 2024-0097)

WHEREAS, the National Privacy Commission (NPC) approved its FY 2024 Annual procurement Plan (APP);

**WHEREAS**, Section 7.1 of the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act No. 9184, otherwise known as the Government Procurement Act, provides that all procurement shall be within the approved budget of the Procuring Entity and should be meticulously and judiciously planned by the Procuring Entity;

WHEREAS, Section 70 of the General Provisions of the 2024 GAA provides that all appropriations authorized in this Act, including budgetary support to GOCCs and financial assistance to LGUs, shall be available for release and obligation for the purpose specified, and under the same general and special provisions applicable thereto, until 13 December 2025, except for personnel services which shall be available for release, obligation and disbursement until 13 December 2024;

**WHEREAS**, the adoption of the Continuing APP of FY 2024, subject to amendments following the submissions of revised approved PPMPs by the different units and divisions upon release of the unit allocation by the Financial Planning and Management division of the NPC, was proposed and approved;

WHEREAS, the NPC received a letter from the Philippine International Convention Center, Inc. informing the former that the office spaces currently occupied by the NPC were among those identified by the ASEAN National Organizing Committee for immediate renovation beginning 15 March 2025 and, therefore, directing the NPC to vacate the premises not later than 14 March 2025;

WHEREAS, the NPC is a national government agency that is mandated in preserving the rights of the data subject which is considered a vital public service;

WHEREAS, given the circumstances stated above, there will be disruption of public services since there will be no government office/facility to cater the public, especially the external frontline services of the NPC;

WHEREAS, Section 53.2 of the IRR allows negotiated procurement during emergency cases where immediate action is necessary to restore public services, infrastructure facilities, and other utilities;
