Under general supervision and with some latitude for the exercise of independent judgement; conducts basic and applied research of technology privacy and security laws, standards and best practices to the assessments of PICs and PIPs to their compliance with NPC privacy and technology standards and issuances, performs technical professional work requiring training, moderate experience and broad knowledge of providing information technology support in implementing DSTSD initiatives such as registration, compliance check, breach notification technology support and compliance advocacy, and researches on current technology, privacy and security issues and trends and relates these to existing NPC policies for their continual improvement and development.

DUTIES AND RESPONSIBILITIES

- 1. Assists the division in developing standards for physical and technical security measure for data protection using most appropriate standard recognized by the information and communications technology industry, including security standards for the processing of sensitive information in government, and recommend amendments of IRR, as may be necessary;
